### STYLES OF DANCE OFFERED:

RAD Certified Ballet, Jazz, Lyrical, Musical Theatre, Tap, Hip Hop, Contemporary and Creative dance.

### PROGRAMS OFFERED

#### RECREATION PROGRAM (Ages 3+)

Our recreational program involves many disciplines of dance. Classes are usually 30-45min and are designed to introduce students to the style of dance they are interested in. Students in Recreational programs perform once a year at the year end recital in June. Along with the tuition fee, a costume fee will be charged in the Spring.

#### COMPETITIVE PROGRAM or PRE-COMPANY PROGRAM (Ages 6+)

Our competitive program allows students to start performing at local competitions once or twice a year. This gives them more opportunities on a stage, and allows them to start to understand how dancing is marked in a competitive atmosphere. In the competitive program, children learn the cooperative teamwork necessary to produce a high quality work of art. They develop creative thinking skills and the ability to push themselves to high levels of achievement. Ballet is a requirement to participate in the competitive program (with the exception of hip hop.) Along with the tuition fee, a competition fee will be charged in November and a costume deposit of \$20 per competitive class will be collected in September and the rest of the costume fees will be charged in January.

#### COMPANY PROGRAM (Age 8+)

Company dancers are experienced dancers who wish to train at a high level in order to prepare for various competitions and shows throughout the season. These dancers must be dedicated, reliable, committed and hard-working. Company groups are taught a Jazz, Lyrical, Hip Hop, Tap and Musical Theatre piece. A company package includes 8-11 hours of training a week and consists of choreography classes and technique classes, 2-3 Ballet classes a week are mandatory; 4 are highly recommended and required for some exam work. These classes are non-negotiable. Typically, company dancers are those who would like to pursue a career in dance whether it be dancing professionally, teaching and choreographing.

Company fees are \$235+GST per month. A \$20 costume deposit is due at the end of September for each competitive costume with the remaining being invoiced in January. Competition fees will be collected by December 1st, 2015.

Company is by audition only. Auditions will be held the first week of September. You will be contacted with your audition time by the beginning of August 2015.

### **IMPORTANT INFORMATION REGARDING FEES:**

Equal Payments: All fees are based on the tuition year (32-35weeks), September 2015-June 2016

A \$25 Registration fee will be charged to all students (once per family).

5% GST must be added on to all prices.

Payment is by **Cash** (3 months at a time), **Post-dated Cheques** (dated the 1st of the month made to Dance Expressions Studio LTD), or **Credit** (2.25% added to all Credit purchases).

There will be a \$15 fee charged for any credit card payments declined and cheques unable to be processed. There will also be a \$15 late fee for any payments not made by the 15th of the month.

A student may take as many classes as they want for a flat rate of \$235 +GST per month.

To withdraw a student from any class, the parent or legal guardian must provide a written notice to the office or by email. Notification must be received before the 20th of the previous month to stop payments.

### **FAMILY DISCOUNT:**

A family discount is given off monthly tuition fees for immediate family members only.

The 2nd family member with the least amount of hours receives a 25% discount.

The 3rd family member with the least amount of hours receives a 50% discount.

PRIVATE REQUEST FORM:

If you wish to book a solo or duo this season, the classes are very limited throughout the week. The Director will do her best to accommodate, but will choose what time slot you have. Guaranteeing a time slot will be considered on a first come first serve basis during the registration period.

It is mandatory for all students to have at least a two hour choreography session over the summer (four hours recommended). This payment is due August 1st, 2015. Please have this payment prepared for the day of registration. In the fall students can request either one 30min bi-weekly session, one 30 min weekly session, or two 30 min weekly sessions. If requesting more than three solos, two 30 minute weekly sessions will be required.

Solo pricing starts at \$30 per 30min session and goes up from there depending on the teacher requested.

Duo pricing starts at \$20 per 30min session per student and goes up from there depending on the teacher requested.
